Livemore is committed to ensuring your privacy is protected. We use information in accordance with the General Data Protection Regulations 2018.

This policy (in conjunction with our Terms and Conditions) explains how we process any personal data we collect from you or that you provide us with.

What is personal information?

Personal information is any information that tells us something about you. This could include information such as name, contact details, date of birth, bank account details or any information about your needs or circumstances which would allow us to identify you.

Some personal information is classified as "special†data under data protection legislation. The includes information relating to health, racial or ethnic origin, religious beliefs or political opinions and sexual orientation. This information is more sensitive and we need to have further justifications for collecting, storing and using this type of personal information. There are also additional restrictions on the circumstances in which we are permitted to collect and use criminal conviction data.

Livemore operate a motion triggered Closed-Circuit television (CCTV) system which is registered with the Information Commissioner under the terms of the Data Protection Act (1998). This system will operate in communal areas and be clearly marked to act as a deterrent against criminal activity and promote a safer environment for all staff and visitors. All personal information collected will be recorded and used in a proper manner in line with the Livemore Data Protection Policy and the General Data Protection Regulations 2018 (GDPR). Information we collect about you

You may give us information about you by completing forms on our site or by corresponding with us by phone, email or otherwise. The information you give us may include (but is not limited to) your name, title, date of birth, address, email address, phone number or other contact information, financial details, and the records and contents of any correspondence and communications you have with us or any feedback which you leave for us.

You acknowledge that the information which you provide to us may amount to sensitive personal data under the General Data Protection Regulations 2018 and you consent to that data being processed as set out in this Privacy Policy.

We may ask for documents in support of Anti Money Laundering such as passports, driving licences and utility bills.

Livemore do not generally use third parties to carry out tasks on their behalf. If it is necessary for third parties to have access to this information this will be purely for the conducting of tasks on Livemore's instructions and not for their own use. We will not disclose your personal information unless obliged to, or allowed to do so by law, or where we need to in order to run our business (e.g. where other people process data for us). In such circumstances, we ask those people to give us confidentiality or non-disclosure undertakings.

Each time you visit our site, we may automatically collect the following information:

- Technical information, including but not limited to the Internet Protocal (IP) address used to connect your computer to the Internet, your login information, browser type and version, time zone setting, browser plug-in types and versions, operating system and platform, identification number, online identifier, location data and other similar identifying information required for your devices to communicate with websites and applications on the internet;
- Information about your visit, including but not limited to the full Uniform Resource Locators (URL) clickstream to, through and from our site (including date and time); products you viewed or searched for; page response times, download errors, length of visits to certain pages, page interaction information (such as scrolling, clocks and mouse-overs), and methods used to browse away from the page and any phone number used to call us.

Information we receive from other sources:

- We may receive information about you if you visit any other websites which we operate or use any services which we provide.
- We are also working with third parties (including, for example, business partners, sub-contractors in technical, payment and delivery services, advertising networks, analytics providers, search information providers and may receive information about you from them.

Cookies

Our website uses cookies to collect standard internet log information and details of visitor behaviour patterns. This information is only processed for analytical purposes and does not identify any user.

The information gathered assists us to continually improve the material and content of our website and services. This ensures that the content of the site is presented in the most effective manner and that we comply with the requirements imposed by law.

Sharing your Information

We may share your information with selected third parties including but not limited to;

• Business partners, suppliers and sub-contractors, for the performance of any contract we enter into with them or with you;

We may disclose your information to third parties:

How we keep your information secure

The security of information is very important to us and we have measures in place which are designed to prevent unauthorised access to your personal information including but not limited to:

- Our client files are stored on our secure client management systems. Access is restricted on our client systems to those within the business who are required to have access to your information for legitimate business purposes.
- Hard copy document is stored appropriately.

All data is hosted in datacentres which have systems and protections in place to protect against both unauthorised access, and other external factors that could cause damage to your personal data. There are strict access requirements in place and access is restricted to those absolutely necessary.

We ensure access to personal information is restricted to Livemore employees and workers or other persons working within Livemore on a need to know basis. Training is provided to those employees and workers who need access to personal information.

Correcting your Personal Information

We will take all reasonable steps in accordance with our legal obligations to update or correct personally identifiable information in our possession. We aim to keep your personal data accurate and

up to date. If you become aware of errors or inaccuracies, please contact us.

The Regulations give you the right to access information held about you. Your right of access can be exercised in accordance with the Regulations. If you wish to see details of any personal information that we hold about you please contact us in writing and we will respond within 30 days.

Changes to this Policy

The Livemore Privacy Policy may change at any time, so you may wish to check it each time you visit our website. This policy was last updated in May 2024.

Transferring your information outside of Europe

As part of the services offered to you the information you provide to us may be transferred to, and stored at, countries outside of the European Union ("EUâ€). By way of example this may happen if any of our servers are from time to time located in a country outside of the EU or one of service providers is located in a country outside of the EU. These countries may not have similar data protection laws to the UK.

You have rights to the following information:

- You have the following additional rights:

- 1. To a copy of the information we hold about you. You can ask us to send this to you or direct to a third party and in commonly used electronic form;
- 2. To rectification or restriction of the way in which we are processing your information; or to object to us processing it;
- 3. To erasure of your personal information provided it is no longer necessary for the purposes for which it was collected; or where there is no legal basis for Livemore processing it;
- 4. Where we have collected information about you from sources other than yourself, information about those sources;
- 5. To ask us whether any decisions are being about you by automated means and if this is happening; information about the logic involved and any significant consequences on you;
- 6. To ask us about the appropriate safeguards we are taking if we transfer your information to a third party or international organisation.
